## **SUMMARY OF TERMS AND CONDITIONS**

- 1. McMahon's Lawn Turf and Maintenance (MLTM) undertakes Risk Assessment Reports for each work site (where deemed necessary), including: obtaining Utility Services' Clearances (Dial Before You Dig) eg Electricity, Gas, Optical, Telstra. The cost of obtaining these Clearances is incorporated in the Quotation Price. If the cost is beyond the standard, the client will be advised and the cost added to the Quotation Price.
- 2. Copies of McMahon's Lawn Turf and Maintenance relevant SWMS, Certificate of Currency for Insurances are available on request.
- 3. A 50% deposit is required on the Acceptance and/or Commencement of the work detailed in the Quotation. The Deposit is non-refundable unless MLTM cannot provide the services listed. The Final Balance is due on the completion of the work, with the issued Final Invoice. If the work is greater than \$4,000.00 payment instalments maybe requested.
- 4. All additional work requested and agreed upon, will be charged over and above the quoted works.
- 5. The Supplier and the Client agree that ownership of the Materials shall not pass until: (a) the Client has paid the Supplier all amounts owing to the Supplier; and (b) the Client has met all of its other obligations to the Supplier. Receipt by the Supplier of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised.
- 6. TURF: No claims recognised after 1 day.
- 7. Turf is generally delivered via truck and/or forklift and all due care is taken during deliveries. You agree to provide access to your property in order to deliver the turf and we will not be held responsible for any damages arising as a result of this. If suitable or safe access to the property is not possible the turf will not be held responsible for any damages arising as a result of this. If suitable or safe access to the property is not possible turf will be delivered to the closest accessible point. When turf is collected by you or your representative from the turf farm, turf comes on pallets and will be loaded with a forklift and/or by hand. You are required to provide suitable transport and restraint for your load. Title of goods does not pass until payment is made in full. Payment is required prior to or on delivery. Information on establishing and maintaining your turf is provided at time of delivery. All advice provided is general in nature and provided in good faith. We We will not be held responsible for any damages arising as a result of not acting within these guidelines/advice. Please note Turf is a natural product grown in an outdoor environment which is subject to the elements, therefore there will always be some variations in the product. Please note that all turf is cut fresh for each order, therefore excess turf cannot be refunded.
